ORDINARY BUSINESS:

1. **Adoption of Annual Accounts:**

To receive, consider and adopt the Audited Balance Sheet as at 31st March, 2026 and Statement of Profit & Loss for the year ended on that date together with report of the Board of Directors and Auditors thereon.

2. **Declaration of dividend:**

To declare final dividend on equity shares of the Company for the financial year ended 31st March, 2026.

3. **Re-appointment of Mr. Arvind Dadha (Holding DIN: 00317631), the retiring director:**

To appoint a director in place of Mr. Arvind Dadha (Holding DIN: 00317631) who retires by rotation and being eligible offers himself for re-appointment.

SPECIAL BUSINESS:

4. **Re-Appointment of Mr. Shashi Ashok Bekal (DIN: 03066170) as an Independent Director**

To consider, and if thought fit, to pass the following resolution as a Special Resolution:

"RESOLVED THAT pursuant to the provisions of Sections 149, 152 read with Schedule IV and other applicable provisions, if any, of the Companies Act, 2013 ("the Act") and the Companies (Appointment and Qualification of Directors) Rules, 2014 (including any amendment, statutory modification(s) or re-enactment(s) thereof for the time being in force) and the applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') as amended from time to time, Mr. Shashi Ashok Bekal (DIN: 03066170), whose term as an Independent Director of the Company expires on June 20, 2026 and who has consented to act as an Independent Director of the Company and has submitted his declaration of complying with the requisite criteria of independence as specified for Independent Director under Section 149(6) of the Companies Act, 2013 and Regulation 16(1)(b) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and pursuant to the recommendation of the Nomination and Remuneration Committee and the Board of Directors made in this regard including the notice received from a member in writing pursuant to Section 160 (1) of the Companies Act, 2013 signifying his intention to propose his candidature for the office of the Director of Company, be and is hereby re-appointed as an Independent Director of the Company for a second consecutive term of 5 years viz. The following perquisites however shall not be included in the computation of the ceiling on remuneration:

NOTES:

1. The Ministry of Corporate Affairs ('MCA') vide its General Circulars No. 20/2020 dated May 5, 2020, 02/2022 dated May 05, 2022, 10/2022 dated December 28, 2022, 09/2023 dated September 25, 2023, 09/2024 dated September 19, 2024 and the latest being 03/2025 dated September 22, 2025 (collectively referred to as 'MCA Circulars'), permitted for conducting the Annual General Meeting ('AGM') of Companies till further order through Video Conferencing ('VC')/Other Audio Visual Means ('OAVM') viz. without the physical presence of the Members at a common venue and the Securities and Exchange Board of India ('SEBI') circulars has also granted certain relaxations to the listed companies regarding such AGMs in terms of Regulations 36 and 44(4) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations'). In compliance with the provisions of the Companies Act, 2013, ('the Act'), MCA Circulars and Listing Regulations as aforesaid, the 36th AGM of the Company is being held through VC/OAVM on Thursday, 20th day of August, 2026 at 3.00 p.m.. Hence, Members can attend and participate in the AGM through VC/OAVM only.
2. The Registered Office of the Company shall be deemed to be the scheduled venue for the AGM.
3. Since the AGM will be held through VC/OAVM, the Route Map for venue of AGM is not annexed to the Notice.
4. Members attending the AGM through VC/OAVM shall be counted for the purpose of reckoning the quorum of the AGM under Section 103 of the Act.
5. In case of joint holders, the Member whose name appears as the first holder in the order of names as per the Register of Members of the Company will be entitled to vote through e-voting and at the AGM, as the case may be.
6. To avoid fraudulent transaction(s), the identity / signature of the Members holding shares in electronic / demat form is verified with the specimen signature(s) furnished by NSDL / CDSL and members holding shares in physical form is verified as per the records of the R&T Agent of the Company. Members are requested to keep the same updated at all times.
7. Pursuant to the provisions of the Act and other applicable Regulations, a member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on their behalf and the proxy need not be a Member of the Company. However, since the AGM is being held through VC/OAVM and not in physical manner pursuant to the aforesaid MCA / SEBI Circulars, physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxies by the Members will not be available for the AGM and hence the Proxy Form and Attendance Slip are not annexed to the Notice.
8. Corporate / Institutional Members (i.e. other than individuals, HUF, NRI, etc.) are required to send a scanned copy (PDF / JPG format) of the relevant Board Resolution / Authority Letter / Power of Attorney etc. together with attested specimen signature of the duly authorised signatory(ies) who is / are authorised to vote, to the Scrutinizer through e-mail at agarwalkala@gmail.com and copy marked to evoting@nsdl.co.in and cs@golkunda.com. The scanned image of the above mentioned documents should be in the naming format "The Golkunda Diamonds & Jewellery Limited".



9. Members holding physical shares are requested to notify change in their address, if any, immediately to the R&T Agent of the Company for proper and timely reach of communication(s) being made by the Company from time to time.
10. Members seeking any information with regard to Register of Directors and Key Managerial Personnel and their shareholding maintained under Section 170 of the Act, Register of Contracts or Arrangements in which directors are interested under Section 189 of the Act, and relevant documents referred to in the accompanying Notice and in the Explanatory Statements are requested to write to the Company on or before Thursday, 14th August, 2026, through email on cs@golkunda.com. The same will be replied by the Company suitably.
11. Pursuant to the requirement of Regulation 36(3) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and respective provisions of Secretarial Standard-2, the brief profile / particulars of the Directors of the Company seeking their reappointment at the AGM is annexed hereto.
12. The Explanatory Statement pursuant to Section 102 of the Act setting out details/material facts relating to the Special Business(es) under Items No. 4 to 7 of the Notice is annexed hereto.
13. In terms of Regulation 40 of Listing Regulations, as amended, the transfer, transmission and transposition of securities shall be effected only in dematerialized mode.

SEBI vide its Circular dated January 30, 2026 has done away with the requirement of issuance of LOC w.e.f. April 2, 2026 to simplify the process for credit of securities pursuant to investor service requests by reducing the timelines, risk of loss and pilferage. The RTA in consultation with the Company will verify and process the service requests and thereafter issue securities to the securities holder/claimant in dematerialized form, directly in the demat account of the securities holder/claimant, within 30 days of its receipt of such request after removing objections, if any. However, the investor service request should be accompanied with a copy of the latest Client Master List ("CML") of the demat account and the CML shall not be older than two months and shall be duly attested by the Depository Participant. Any LOC issued before April 02, 2026, may be submitted by the investors to Depository Participant for dematerialization within the specified timeline i.e. 120 days from the date of issuance of LOC.

In view of above and to eliminate all risks associated with the transfer of physical shares and for ease of portfolio management, Members holding shares in physical mode are requested to first complete their KYC with KFin by way of filing form ISR1, ISR2, ISR3 or Nomination Form SH13, ISR4 etc. and thereafter they should convert their shareholdings into electronic mode at the earliest. Members can contact MUFG Intime India Pvt. Ltd. for any assistance in this regard.

14. In terms of SEBI Circulars / Regulations, it is now mandatory to furnish a copy of PAN card to the Company or its R&T Agent in case of transactions related to deletion of name, transmission of shares and transposition of shares, hence members are requested to furnish copy of their PAN card while proceeding for such transactions.
15. Members holding shares in the same name under different Ledger Folios are requested to apply for consolidation of such folios and send the relevant share certificate(s) to the R&T Agent of the Company for enabling them to consolidate the shares in accordance with due process thereof.
16. In terms of Section 72 of the Act, the facility for making nomination is available for the Members in respect of the shares held by them. Members who have not yet registered their nomination are requested to register the same by submitting Form No. SH-13. Members are requested to submit the said details to their DP in case the shares are held by them in electronic form and to MUFG Intime India Private Ltd., in case the shares are held in physical form by sending an email to rnt.helpdesk@in.mpms.mufg.com.
17. The SEBI Listing Regulations have mandated the Companies to credit the dividends electronically to the Members' Bank Account. Members who hold shares in electronic / dematerialized form should inform their Depository Participant (DP) and those Members holding shares in physical form should inform to the Company or its R&T Agent, their bank details viz. Bank Account Number, Name of the Bank and Branch details, IFSC Code and MICR Code to enable the Company to incorporate the same for purpose of dividend payments electronically. Those Members who have already provided their bank details but if there is any change therein, they should also update the same instantly in the manner as aforesaid. The members of Company, as per SEBI Circular dated 17.11.2023, should note that no dividend warrant will be despatched by Company to the Members w.e.f. April 1, 2024 for payment of dividends, if any, if they have not completed their KYC with the Company or its RTA or respective depositories and in such a case, the unpaid dividend amount will be transferred to the Unpaid Dividend Account of the Company opened with any scheduled bank in terms of the applicable provisions of the Listing Agreement or Companies Act, 2013, as may be applicable. Such member(s), however, will get a notification from the Company about status of their KYC and only after completion of their KYC, their unpaid dividend(s) amount will be released directly to the bank account(s) of respective member(s) electronically.
18. The Company will not entertain any direct request from Member(s) for deletion/change in their bank details. Members may, therefore, give instructions regarding bank accounts in which they wish to receive the dividend, directly to their Depository Participants/Company/RTA of the Company, as the case may be.
19. If the final dividend, as recommended by the Board of Directors, if approved at the AGM, payment of such dividend will be made on or after Thursday, August 27, 2026 to all the eligible shareholders who hold shares of the Company as on the record date viz. at the close of business hours on Thursday, August 20, 2026 (for de-mat and physical shareholders both).



20. Pursuant to Finance Act 2020, dividend income is taxable in the hands of shareholders w.e.f. April 1, 2020 and the Company is required to deduct tax at source from dividend paid to shareholders at the prescribed rates. For the prescribed rates as applicable to various categories, the shareholders are requested to refer to the respective legal provisions of Income Tax Act, as amended thereto and / or consult with their tax advisor. However, some features of tax provisions applicable on dividend distribution are stated as hereunder for a quick reference / general awareness of the Members.

For Resident Shareholders, tax shall be deducted at source under Section 194 of the Income Tax Act, 1961 @ 10% on the amount of Dividend declared and paid by the Company during financial year 2025-26 provided PAN is provided by the shareholder. If PAN is not submitted, TDS would be deducted @ 20% as per Section 206AA of the Income Tax Act, 1961.

However, no TDS shall be deducted on the dividend payable to a resident Individual if the total dividend to be received by them during Financial Year 2025-26 does not exceed R 5,000/-. Please note that this includes the previous dividend(s) paid, if any, and future dividend(s) which may be paid, during the Financial Year 2025-26, if declared.

In cases where the shareholder provides Form 15G (applicable to any person other than a Company or a Firm) / Form 15H (applicable to an Individual above the age of 60 years), provided that the eligibility conditions are being met, no tax at source shall be deducted.

Apart from the above, since the TDS / Withholding rates are different for resident and non-resident shareholders, members are requested to confirm their residential status as per the provisions of the Income Tax Act 1961, by sending an email at rnt.helpdesk@in.mpms.mufg.com with copy to cs@golkunda.com

Post payment of the Dividend amount, the soft copy of TDS certificate of the Members may be sent at their registered email ID, and in remaining cases, where no email ID of Member is registered, TDS certificates may be posted to the Member(s) address recorded with the Company, as may be required.

However, if the shareholder(s) do not receive TDS certificate for any reason, whatsoever, they can directly write a mail to the Company at cs@golkunda.com for the same.

In view of above provisions, the shareholders are requested to update their PAN with the Company / R&T Agent (in case shares held in physical mode) and with the depositories (in case of shares held in de-mat mode). A Resident individual shareholder with PAN but not liable to pay income tax can submit a yearly declaration in Form No. 15G/15H in the aforesaid manner, to avail the benefit of non-deduction of tax at source, by sending an email to cs@golkunda.com upto Thursday, August 13, 2026 (5.00 p.m. IST) with copy to rnt.helpdesk@in.mpms.mufg.com

Non-resident shareholders can avail beneficial rates under tax treaty between India and their country of residence, subject to providing necessary documents i.e. No Permanent Establishment and Beneficial Ownership Declaration, Tax Residency Certificate, Form 10F or any other document which may be required to avail the tax treaty benefits under the provisions of Income Tax Act, 1961, by sending an email to rnt.helpdesk@in.mpms.mufg.com with copy to cs@golkunda.com upto 5.00 p.m. (IST) Thursday, August 13, 2026.

21. Shareholders who have not yet en-cashed their dividend warrant(s) for the financial year 2018-19 and/or any subsequent financial years, are requested to submit their claim to MUFG Intime India Private Limited immediately to avoid transferring of their unpaid dividend amount to IEPF Account.

Members are further requested to note that pursuant to the provisions of Section 124 and 125 of Companies Act, 2013, the dividends if not en-cashed for a period of 7 years consecutively from the date of transfer to Unpaid Dividend Account of the Company, are liable to be transferred to the Investor Education and Protection Fund (IEPF) and the shares in respect of which dividends remain unclaimed for seven consecutive years are also liable to be transferred to the de-mat account of the IEPF Authority and no claim with the Company shall lie in respect thereof. In view of this, Members are requested to claim their dividends from the Company, within the stipulated timeline. EXPLANATORY STATEMENT UNDER SECTION 102(1) OF THE COMPANIES ACT, 2013

ITEM NO. 4

Mr. Shashi Ashok Bekal was appointed as an Independent Director of the Company for a consecutive term of 5 years w.e.f. June 21, 2021 and he was not liable to retire by rotation. His said appointment is due to expire on June 20, 2026. Pursuant to the provisions of section 149(10) of the Companies Act, 2013, an Independent Director shall be eligible for re-appointment for second term on passing of a Special Resolution by the Company. Further regulation 25 (2A) of the Listing Regulations also mandates for special resolution for appointment of any person as Independent Director of the company. The Company has received a notice in writing from a Member of the Company under section 160(1) of the Companies Act, 2013 proposing the candidature of Mr. Shashi Ashok Bekal for the office of Director of the Company. Mr. Shashi Ashok Bekal has given consent for the said re-appointment and is not disqualified for same in terms of the provisions of Section 164 of the Companies Act, 2013 ("Act"). Further, the Company has received declaration of independence from Mr. Shashi Ashok Bekal confirming that he meets the criteria of independence as specified in Section 149 (6) of the Act and Regulation 16 (1) (b) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and that he is not aware of any circumstance or situation, which exist or may be reasonably anticipated, that could impair or impact his ability to discharge his duties with an objective independent judgement and without any external influence. Mr. Shashi Ashok Bekal has also given a declaration that he is not debarred from holding the office of Director by virtue of any SEBI order or any other such authority. On the basis of report of performance evaluation of Mr. Shashi Ashok Bekal, the Nomination and Remuneration Committee recommended to the Board that his continued association will immensely benefit the Company. Pursuant to the recommendation of Nomination and Remuneration Committee so made and their performance evaluation report issued regarding Mr. Shashi Ashok Bekal and also in order to reap benefits of his skills, extensive and enriched experience, the Board is of the opinion that, Mr. Shashi Ashok Bekal is a suitable person for the office of Independent Director of the company and also fulfills the conditions of his appointment as Independent Director in terms of the applicable provisions of Companies Act, 2013 and Listing Regulations, . The terms and conditions of his appointment shall be open for inspection by the Members at the Registered Office of the Company during the normal business hours on any working day.

In view of above and also considering provisions of 17(1A) of Listing Regulations, the said resolution at item Nos. 4 is being recommended by the Board of Directors to the members of the Company for their consideration and accord approval thereto by way of a Special Resolution.

None of the Directors and Key Managerial Personnel of the Company or their relatives except Mr. Shashi Ashok Bekal, relating to his own appointment, may be deemed to be concerned or interested in the Resolution stated at item no.4 of the Notice.

The extant term of appointment of 3 (three) years of Mr. Kanti Kumar Dadha (DIN:00283289) aged 78 years as Chairman and Whole Time Director is due to expire on 30th September, 2023. Having regards to his in-depth, multifaceted and enriched knowledge and experience in the arena of Diamonds, Gems & Jewellery Business(es) and likelihood of substantive growth of the business of the Company under his apt guidance and stewardship, it is proposed, subject to approval of members of the Company in the General Meeting and receipt of other requisite approvals, if any, to re-appoint Mr. Kanti Kumar Dadha as Chairman and Whole Time Director of the Company for a further period of 3 (Three) years w.e.f. 1st October, 2026. The re-appointment and remuneration has been approved by the Board of Directors and Nomination & Remuneration Committee in their respective meetings held on 28th May, 2026 and stands recommended by Board for seeking approval of members for the said re-appointment of Mr. Kanti Kumar Dadha.

Pursuant to the provisions of Sections 196, 197, 198 and any other applicable provisions, if any, of the Act and the Rules framed thereunder read with Schedule V to the Act, the appointment and remuneration of Chairman and whole time Director, since exceeding the age of 78 years, requires approval of the members of the Company by way of special resolution.

An Independent Director shall possess appropriate skills, experience and knowledge in one or more fields of finance ,law, management, sales, marketing, administration, research, corporate governance, operations or other disciplines related to the Company's business.



ii) **Positive attributes of Independent Directors:**

An independent Director shall be a person of integrity, who possesses relevant expertise and experience and who shall uphold ethical standards of integrity and probity; act objectively and constructively; exercise his responsibilities in a bona-fide manner in the interest of the Company; devote sufficient time and attention to his professional obligations for informed and balanced decision making; and assist the Company in implementing the best corporate governance practices.

1. **Removal:**

Due to reasons for any disqualification mentioned in the Act or under any other applicable Act, rules and regulations there under, the Committee may recommend, to the Board with reasons recorded in writing, removal of a Director, KMP or Senior Management Personnel subject to the provisions and compliance of the said Act, rules and regulations.

2. **Retirement:**

The Director, KMP and Senior Management Personnel shall retire as per the applicable provisions of the Act and the prevailing policy of the Company. The Board will have the discretion to retain the Director, KMP, Senior Management Personnel in the same position/ remuneration or otherwise even after attaining the retirement age, for the benefit of the Company.

II. **Remuneration:**

1. **Directors:**

a) **Executive Directors (Managing Director, Manager or Whole Time Director):**

i) At the time of appointment or re-appointment, the Executive Directors shall be paid such remuneration as may be mutually agreed between the Company (which includes the Nomination and Remuneration (N&R) Committee and the Board of Directors) within the overall limits prescribed under the Companies Act, 2013.

ii) The remuneration shall be subject to the approval of the Members of the Company in General Meeting as per the requirement of the Companies Act, 2013.

iii) The remuneration of the Manager /CEO /Managing Director /Whole Time Director is broadly divided into fixed and incentive pay reflecting short and long term performance objectives appropriate to the working of the Company. In determining the remuneration (including the fixed increment and performance bonus), the Committee shall consider the following:

- * the relationship of remuneration and performance benchmark;
- * balance between fixed and incentive pay reflecting short and long term performance objectives, appropriate to the working of the Company and its goals;
- * responsibility required to be shouldered, the industry benchmarks and the current trends;
- * The Company's performance vis-a-vis the annual budget achievement and individual performance.

b) **Non-Executive Director:**

* The Non-Executive Independent Director may receive fees for attending meeting of Board or Committee thereof. Provided that the amount of such fees shall not exceed Rupees One Lakh per meeting of the Board or Committee or such amount as may be prescribed by the Central Government from time to time.

* A Non-Executive Director may be paid commission on an annual basis, of such sum as may be approved by the Board on the recommendation of the Committee.

* The Committee may recommend to the Board, the payment of commission, to reinforce the principles of collective responsibility of the Board.

* In determining the quantum of commission payable to the Directors, the Committee shall make its recommendation after taking into consideration the overall performance of the Company and the onerous responsibilities required to be shouldered by the Director. The total commission payable to the Directors shall not exceed prescribed limits as specified under Companies Act, 2013.

* The commission shall be payable on pro-rata basis to those Directors who occupy office for part of the year.

2. **KMP & Senior Managerial Personnel:**

The remuneration to the KMP and Senior Management Personnel will be based on following guidelines:

- * maintaining a balance between fixed and incentive pay reflecting short and long term performance objectives appropriate to the working of the Company;



- * compensation should be reason able and sufficient to attract retain and motivate KMP and senior management;
- * Remuneration payable should comprise of a fixed component and a performance MUFG variable based on the extent of achievement of individual performance versus overall performance of the Company;
- * Remuneration shall be also considered in form of long term incentive plans for key employees, based on their contribution, position and length of service, in the nature of ESOPS/ESPS.

II. Evaluation:

The Committee shall carry out evaluation of performance of every Director at regular interval (yearly).The Committee shall also formulate and provide criteria for evaluation of Independent Directors and the Board as a whole, if applicable.

MANAGEMENT DISCUSSION AND ANALYSIS

1. GLOBAL ECONOMIC OVERVIEW

During FY 2025-26, the global economy demonstrated resilience despite persistent geopolitical uncertainties, evolving trade policies, inflationary pressures and volatility across commodity markets. While most major economies experienced low to moderate growth, elevated inflation, partly driven by oil price fluctuations and heightened global uncertainties, continued to impact economic activity. Geopolitical tensions in various regions and ongoing disruptions in global supply chains also influenced business sentiment and international trade flows.

India continued to remain one of the fastest-growing major economies, supported by robust domestic consumption, favourable demographic trends and continued government-led initiatives. Sustained investments in infrastructure, manufacturing and digital transformation, coupled with stable macroeconomic fundamentals, further strengthened the country's growth outlook.

The global gems and jewellery industry experienced varied market conditions during the year. While fluctuations in gold prices and broader economic uncertainties impacted discretionary spending in certain markets, demand for branded jewellery, diamond jewellery and premium lifestyle products remained comparatively resilient. Meanwhile, increasing digital adoption, changing consumer preferences and greater emphasis on product quality and responsible sourcing continued to shape the industry's long-term growth and evolution.

2. OPPORTUNITIES AND THREATS

Opportunities

- Expansion into new export markets and strengthening of relationships with existing customers, particularly in countries benefiting from new Free Trade Agreements and favourable trade arrangements.
- Growing domestic demand for jewellery, supported by rising disposable incomes, rapid urbanisation and evolving consumer preferences.
- Establishment of a domestic jewellery manufacturing facility to cater to the expanding Indian market while diversifying the Company's revenue streams and customer base.
- Potential Free Trade Agreements and bilateral trade arrangements with major developed economies are expected to enhance export competitiveness and open new avenues for business growth.
- Increasing consumer preference for branded, premium and value-added jewellery, creating opportunities for product diversification and enhanced value creation.
- Greater adoption of advanced manufacturing technologies, automation and digital platforms to improve operational efficiency, productivity and customer engagement.

Threats

- Geopolitical uncertainties and global economic disruptions that could adversely affect business sentiment and international trade.
- Tariff barriers, protectionist policies and international trade restrictions that may impact export competitiveness and market access.
- Volatility in gold, diamond and other precious metal prices, which may impact input costs and operating margins.
- Foreign exchange rate fluctuations could affect export realisations and overall profitability.
- Intensifying competition from domestic as well as international jewellery manufacturers, leading to pricing and margin pressures.
- Changes in consumer spending patterns for luxury products

3. OUTLOOK

A. Global Economic Outlook

The global economic outlook is expected to remain cautious amid continuing geopolitical tensions and trade-related uncertainties. While global growth is likely to remain moderate, it is expected to be supported by sustained investments in technology and infrastructure, and the potential conclusion of new trade agreements that could strengthen global trade and investment flows.

B. Global Jewellery Market Forecast

The global jewellery market is expected to continue its growth momentum, supported by rising consumer spending, increasing demand for premium and branded jewellery, wider acceptance of lab-grown diamonds and the rapid expansion of digital retail platforms. In addition, sustained demand from emerging economies, particularly across Asia and the Middle East, is expected to remain a key driver of the industry's long-term growth, creating new opportunities for jewellery manufacturers and exporters.



C. India Economic & Jewellery Forecast 2026-27

India is expected to remain one of the fastest-growing major economies globally during FY 2026-27, with GDP growth projected to exceed 6% by several leading global financial institutions. Supported by robust domestic consumption, sustained infrastructure development and favourable demographic trends, India is expected to retain its position as the world's fastest-growing major economy. Continued government focus on manufacturing, infrastructure and export promotion is also expected to provide a strong impetus to industrial growth.

The Indian jewellery industry is well positioned for sustained growth, driven by rising disposable incomes, increasing consumer preference for branded jewellery, the continued expansion of organized retail and evolving lifestyle and consumption patterns. These structural trends are expected to create significant opportunities for organized jewellery manufacturers and retailers.

The Company remains optimistic about its long-term growth prospects. While continuing to strengthen its export business, it plans to enhance its presence in the domestic market during the coming financial year. This strategic expansion is expected to create a more balanced revenue mix, diversify the customer base, improve business resilience and support sustainable long-term value creation for all stakeholders.

4. RISKS AND CONCERNS

Impact of Tariffs on Jewellery Trade to the USA from India

The United States continues to be one of the largest export destinations for India's gems and jewellery industry. Any increase in import duties, tariff barriers, trade restrictions or changes in bilateral trade policies may affect the competitiveness of Indian jewellery exports in the U.S. market. Such measures may result in pricing pressures, changes in customer procurement strategies and potential impact on export volumes.

Impact of USA-Iran-Israel Conflict

Escalating geopolitical tensions involving the United States, Iran and Israel may adversely affect global economic stability, international trade flows, commodity prices and investor sentiment. Such developments may lead to increased volatility in gold prices, higher logistics and freight costs, disruption in shipping routes and fluctuations in foreign exchange markets.

Other Business Risks

The Company's operations are subject to various business risks, including fluctuations in gold and diamond prices, foreign exchange rate movements, evolving consumer preferences, changes in the regulatory environment and increasing competitive pressures. The Company continuously monitors these risks and has implemented appropriate risk management systems and internal processes to mitigate their potential impact and support the continuity and stability of its business operations.

5. INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY

The Company has established a robust internal control framework that is commensurate with the size, nature and complexity of its business operations. These controls are designed to facilitate efficient and orderly conduct of business, safeguard the Company's assets, prevent and detect frauds and errors, ensure the accuracy and completeness of accounting records, and enable the timely preparation of reliable financial information.

The adequacy of the internal control systems are periodically evaluated through a comprehensive internal audit process and regular management reviews. Key audit findings and recommendations are presented to the Audit Committee, which oversees the implementation of appropriate corrective and preventive measures to further strengthen the Company's control environment.

6. PERFORMANCE OVERVIEW

During the Financial Year 2025-26, the Company sustained its growth momentum despite operating in a challenging global economic environment characterised by volatility in precious metal and diamond prices. The business also faced significant headwinds arising from geopolitical developments, including the imposition of higher import tariffs on jewellery by the United States, the Iran conflict and the continuing Russia-Ukraine war, all of which impacted global trade and market sentiment.

Despite these challenges, the Company delivered improved revenue and profitability, demonstrating the resilience of its business model and operational strength. Its performance was supported by long-standing customer relationships, a well-diversified export market presence, disciplined inventory management and an unwavering commitment to quality, operational excellence and timely delivery.

During the year under review, the Company recorded Net Sales / Income from Business Operations of ₹281.51 crores, as against ₹252.44 crores in the previous financial year, representing a growth of approximately 11.51%. Profit has increased to 13.69 crores from 11.81 crores an increase of 15.91 %

The Company remains committed to expanding its product portfolio, strengthening customer engagement and improving operational efficiencies. The proposed domestic jewellery manufacturing unit is expected to provide an additional growth avenue and further strengthen the Company's long-term business prospects.



Domestic Market Expansion Strategy

As part of its strategic growth initiatives, the Company has established a new manufacturing facility at Andheri, Mumbai, to strengthen its presence in the domestic market. This investment reflects the Company's focus on broadening its revenue base by leveraging the manufacturing expertise and capabilities it has developed over the last four decades.

The new facility will manufacture and supply a comprehensive range of fine jewellery, including diamond, gold, gemstone, jadau and lab-grown diamond jewellery, to leading retail chains and organised jewellery retailers across major cities in India, enabling the Company to effectively cater to the growing demand in the domestic market.

Backed by over 40 years of experience in manufacturing and exporting fine jewellery, the Company has built strong and enduring relationships with renowned retail chains across Europe and the Middle East. Leveraging its proven manufacturing capabilities and industry expertise, the Company believes that expanding into selected high-growth segments of the Indian jewellery market is a natural extension of its business strategy.

The Company also aims to strengthen its position in the rapidly growing lab-grown diamond segment by offering premium-quality jewellery that reflects evolving consumer preferences. In line with its long-term growth strategy, the Company is also exploring strategic partnerships, alliances and acquisition opportunities to accelerate its entry into the B2C retail business.

To support the action plan, the Company raised funds through a preferential allotment of convertible warrants with the objective of maintaining adequate liquidity to support the timely execution of its expansion plans. The capital infusion is expected to facilitate the establishment and scaling up of the new manufacturing facility, strengthen working capital, and ensure the smooth implementation of the Company's strategic initiatives without financial constraints, thereby enabling accelerated and sustainable business growth.

This expansion is expected to enhance the Company's presence in the domestic market, diversify its customer base and reduce its dependence on export markets. It is also anticipated to create sustainable long-term growth opportunities and further strengthen the Company's competitive position within the Indian jewellery industry.

Notes to the financial statements for the year ended 31st March, 2026

Note: 1 - Significant Accounting Policies:

1 Company overview:

The Golkunda Diamonds & Jewellery Limited ("the Company") is public limited company incorporated and domiciled in India and has registered office at G-30, Gems & Jewellery Complex-III, SEEPZ, Andheri (East). It is incorporated under the Indian Companies Act, 1913 and its shares are listed on the Bombay Stock Exchange Limited (BSE) in India. The company is engaged in manufacturing of Studded Jewellery & Dealing in Cut & Polished Diamonds, Precious and Semi Precious stones.

The financial statements are approved for issue by the Company's Board of Directors on 28th May, 2026.

2 Statement of Compliance :

These financial statements have been prepared in accordance with the Indian Accounting Standards (hereinafter referred to as the Ind AS') as

notified by Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 ('Act') read with the Companies (Indian Accounting

Standards) Rules, 2015 as amended and other relevant provisions of the Act.

The accounting policies are applied consistently to all the periods presented in the financial statements.

3 Basis of Accounting :

All financial items of Income and Expenditure having a material bearing on the financial statement are recognised on accrual basis, except income by way of dividend and expense by way of leave encashment which is accounted on cash basis.

4 Presentation of financial statements :

The Balance Sheet and the Statement of Profit and Loss are prepared and presented in the format prescribed in the Schedule III of the Companies Act, 2013 (the "Act"). The statement of cash flows has been prepared and presented as per the requirements of Ind AS 7 "Statement of Cash flows". The disclosure requirements with respect to items in the Balance Sheet and Statement of Profit and Loss, as prescribed in the Schedule III to the Act, are presented by way of notes forming part of the financial statements along with the other notes required to be disclosed under the notified Accounting Standards and the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015.

Rounding off

All amounts disclosed in the financial statements and notes have been rounded off to the nearest Lacs.

5 Sales :

Sales exclude GST, Transportation, Penalty/Late delivery charges and include Insurance, Freight, Sales Returns and Discount.

6 Use of Estimates :

The preparation of Financial Statements in conformity with the Accounting Standards generally accepted in India requires, the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities as at the date of the financial statements and reported amounts of revenue and expense for the year. Actual results could differ from these estimates. Any revision to accounting estimates is recognised prospectively in current and future periods.

7 Property, Plant & Equipment (PPE) :

- i) All PPE are valued at cost less depreciation. The cost is inclusive of incidental expenses related to acquisition and put to use. Pre-operative expenses including trial run expenses (net of revenue) are capitalised. Interest on borrowings and financing costs during the period of construction is added to cost of fixed assets.
- ii) Impairment loss, if any is recognised in the year in which impairment takes place.
- iii) Depreciation on PPE is provided on Straight Line Value Method at the rate and in the manner specified in Schedule II of the Companies Act, 2013.
- iv) Depreciation on additions / disposals of the PPE during the year is provided on pro-rata basis according to the period during which assets are put to use.



8 Intangible Assets :

Intangible assets are recognised when it is probable that the future economic benefits that are attributable to the asset will flow to the Company and the cost of the asset can be measured reliably.

9 Expenditure during the Construction Period :

The expenditure incidental to the expansion / new projects are allocated to Fixed Assets in the year of commencement of the commercial production.

10 Operating cycle for current and non-current classification :

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III to the Companies Act, 2013. Based on the nature of transaction, the Company has ascertained its operating cycle as 12 months for the purpose of current / non-current classification of assets and liabilities.

11 Inventories :

Raw Materials, Stores & Spare Parts and Finished Goods are valued at lower of cost and net realisable value.

12 Cash and Cash Equivalents :

Cash and cash equivalent in balance sheet comprise cash at banks, cash on hand and short term deposits with original maturity of three months or less, which are subject to an insignificant risk of changes in value. For the purpose of the statement of cashflows, cash and cash equivalents consist of cash and short term deposits.

13 Borrowing Costs

Borrowing costs consist of interest and other costs that the Company incurs in connection with the borrowing of funds. Also, the EIR amortisation is included in finance costs. Borrowing costs relating to acquisition, construction or production of a qualifying asset which takes substantial period of time to get ready for its intended use are added to the cost of such asset to the extent they relate to the period till such assets are ready to be put to use. All other borrowing costs are expensed in the Statement of Profit and Loss in the period in which they occur

14 Revenue Recognition :

a Sale of goods and services :

The Company is engaged in manufacturing of Studded Jewellery.

The Company recognises revenue from sale of products when significant risk and rewards are transferred to customer, which is usually when control of the products has transferred, when the products are delivered to the customer. Delivery occurs when the products have been shipped or delivered to the specific location as the case may be, the risks of loss has been transferred, and either the customer has accepted the products in accordance with the sales contract, or the Company has objective evidence that all criteria for acceptance have been satisfied.

Interest income is accounted on accrual basis and Dividend income is recognised when the unconditional right to receive the income is established.

Fixed Deposit interest is accounted as per Certificate / Statement / documents issued by the respective parties inclusive of tax deducted at source.

15 Income Tax

Income tax comprises of current and deferred income tax. Income tax is recognised as an expense or income in the Statement of Profit and Loss, except to the extent it relates to items directly recognised in equity or in OCI.

a Current Income Tax

Current income tax is recognised based on the estimated tax liability computed after taking credit for allowances and exemptions in accordance with the Income Tax Act, 1961. Current income tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date.

b Deferred Income Tax

Deferred tax is determined by applying the Balance Sheet approach. Deferred tax assets and liabilities are recognised for all



deductible temporary differences between the financial statements' carrying amount of existing assets and liabilities and their respective tax base. Deferred tax assets and liabilities are measured using the enacted tax rates or tax rates that are substantively enacted at the Balance Sheet date. The effect on deferred tax assets and liabilities of a change in tax rates is recognised in the period that includes the enactment date. Deferred tax assets are only recognised to the extent that it is probable that future taxable profits will be available against which the temporary differences can be utilised. Such assets are reviewed at each Balance Sheet date to reassess realisation.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

16 Foreign Currency Transactions :

Initial recognition :

The Company's financial statements are presented in INR, which is also the Company's functional currency. Transactions in foreign currencies are recorded on initial recognition in the functional currency at the exchange rates prevailing on the date of the transaction.

Measurement at the balance sheet date :

Non-monetary items which are carried at historical cost denominated in a foreign currency are reported using the exchange rate at the date of the transaction. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value is determined.

Treatment of exchange difference :

Exchange differences that arise on settlement of monetary items are recognised as income or expenses in the period in which they arise.

17 Post-employment, long term and short term employee benefits :

Defined contribution plans :

Provident fund benefit is a defined contribution plan under which the Company pays fixed contributions into funds established under the Employees' Provident Funds and Miscellaneous Provisions Act, 1952, for the eligible employees. The Company has no legal or constructive obligations to pay further contributions after payment of the fixed contribution. The Company's contributions to defined Contributions Plans are charged to the Profit & Loss account.

Defined benefit plans :

The Company has defined Benefit Plan for post-employment benefit in the form of Gratuity for eligible employees, defined under The Payment of Gratuity Act, 1972. The liability recognised in the financial statements in respect of gratuity is the present value of the defined benefit obligation at the reporting date, together with adjustments for unrecognised actuarial gains or losses and past service costs. The defined benefit/obligation is calculated at or near the reporting date by an independent actuary using the projected unit credit method.

Actuarial gains and losses arising from past experience and changes in actuarial assumptions are credited or charged to the OCI in the year in which such gains or losses are determined.

Other long-term employee benefits :

Leave Liability :

The employees of the company are entitled to leave as per the leave policy of the company. The liability on account of accumulated leave as on last day of the accounting year is not recognised.

Short-term employee benefits :

Expense in respect of any other short term benefits, other than above, is recognised on the basis of the amount paid or payable for the period during which services are rendered by the employee.

18 Employee Separation Costs :

The compensation paid to the employees under Voluntary Retirement Scheme is expensed in the year of payment.

19 Provision for Bad and Doubtful Debts / Advances :

Provision, if any, is made in accounts for bad and doubtful debts / advances which in the opinion of the management are considered doubtful of recovery.



20 Dividend distribution to Equity Shareholders :

Dividend distribution to Equity Shareholders is recognised as distribution to owners of capital in the Statement of Changes in Equity, in the period in which it is paid.

21 Deferred Tax Assets:

In assessing the realisability of deferred income tax assets, management considers whether some portion or all of the deferred income tax assets will not be realized. The ultimate realization of deferred income tax assets is dependent upon the generation of future taxable income during the periods in which the temporary differences become deductible. Management considers the scheduled reversals of deferred income tax liabilities, projected future taxable income and tax planning strategies in making this assessment. Based on the level of historical taxable income and projections for future taxable income over the periods in which the deferred income tax assets are deductible, management believes that the Company will realize the benefits of those deductible differences. The amount of the deferred income tax assets considered realizable, however, could be reduced in the near term if estimates of future taxable income during the carry forward period are reduced.

22 Provisions, Contingent Liabilities and Contingent Assets :

Provisions :

Provisions are recognised when the company has a present obligation (legal or constructive) as a result of a past events and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimates can be made of the amount of the obligation. The expense relating to a provision is presented in the Statement of Profit and Loss.

Contingent Liabilities :

Contingent liability is disclosed for (i) Possible obligations which will be confirmed only by the future events not wholly within the control of the company or (ii) Present obligations arising from past events where it is not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount of the obligation cannot be made.

Contingent Assets :

Contingent assets are neither recognised nor disclosed in the financial statements.

23 Rent Income / Expense :

The Company is paying/receiving the rent as per the agreement for lease executed with the respective lessee. The rent is fixed from the date of execution of lease agreements. The payment/receipt for the same is made year after year. Payments/receipts made under operating leases are recognised in profit or loss on a straight line basis over the term of the lease unless such payments/receipts are structured to increase in line with expected general inflation to compensate for the lessor's expected inflationary cost increase.

24 Statement of Cash Flows :

Statement of Cash Flows is prepared segregating the cash flows into operating, investing and financing activities. Cash flow from operating activities is reported using indirect method, adjusting the net profit for the effects of:

- i. changes during the period in inventories and operating receivables and payables transactions of a non-cash nature;
- ii. non-cash items such as depreciation, provisions, unrealised foreign currency gains and losses etc
- iii. all other items are considered as either investing or financing cash flows.

25 Derivative contracts and hedge accounting :

Other derivatives :

The Company uses foreign exchange forward contracts to hedge its exposure towards foreign currency. These foreign exchange forward contracts are not used for trading or speculation purposes. A derivative contract is not recognised as an asset or a liability on the commitment date. Outstanding derivative contracts as at reporting date are fair valued and recognised as financial asset/financial liability, with the resultant gain/(loss) being recognised in the statement of profit and loss under OCI.

26 Earnings per Share :

Basic Earnings per share is calculated by dividing the net profit for the period attributable to the equity shareholders by the weighted average number of equity shares outstanding during the period. For the purpose of calculating diluted earnings pershare, the net profit for the period attributable to the equity shareholders and the weighted average number of equity shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares.



- 27** The Ministry of Corporate Affairs ("MCA") has notified the amendments to Ind AS 116 "Leases" effective for annual periods beginning on or after April 1, 2019. Ind AS 116 'Leases' eliminates the classification of leases as either finance leases or operating leases. All leases are required to be reported on an entity's balance sheet as assets and liabilities. Leases are capitalised by recognising the present value of the lease payments and showing them either as right of use of the leased assets or together with property, plant and equipment. If lease payments are made over a period of time financial liability representing the future obligation would be recognised.

As per Ind AS 116, the lessee needs to recognise depreciation on rights of use of assets and finance costs on lease liabilities in the statement of profit and loss. The lease payments made by the lessee under the lease arrangement will be adjusted against the lease liabilities. The Company has not adopted Ind AS 116 "Lease" during the year 2025-26 and is still in the process of evaluating the impact of adoption of the same on its financial statements.
